Dr. Christos Floros is a member of the Board of Governors of the **Hellenic Mediterranean University (HMU)**. He is a Professor of Finance in the **Department of Accounting and Finance (ACCFIN)** of the School of Management and Economics of HMU and Director of the MSc programmes in "**Accounting and Auditing**" and "**Financial Management**". He is also the Director of the Research Laboratory in "Accounting and Financial Management" (**LAFIM**), as well as Director of the Institute of Economic Analysis, Entrepreneurship and Tourism of **HMU Research Center**. Prof. Floros was elected Vice-Rector of Research (2017-2022) and Head of the ACCFIN Department (2015-2017). Professor Christos Floros holds a PhD in Finance (Swansea University) and Masters Degrees in Mathematics (MSc, University of Portsmouth) and Business Economics (MA, University of Portsmouth), as well as a BSc in Mathematics and Operational Research (BSc, University of Brighton). His main research interests include finance, financial economics, financial derivatives, financial econometrics, modern banking and applied economics. His research work is distinguished by the high number of citations (5400, h-index 38), while he is included among the leading academic economists in Greece according to the ranking of the Stanford international list (2% of researchers worldwide), RePEc/IDEAS and the AD Scientific Index. He has published over 100 articles in many prestigious international scientific journals, has presented numerous research papers at International conferences, has taken part as a Keynote Speaker and co-organizer of Conferences and has participated in many scientific committees of International Conferences. Professor Christos Floros is Editor of **IJFMD** and **IJCEE** of Inderscience and participates as a member of Editorial Boards of academic journals. He has completed various research projects as coordinator and principal investigator, while he has successfully supervised postdoctoral and doctoral students. He has also published four academic books on "**Financial Derivatives**" (DISIGMA Publications), "**Modelling and Forecasting High Frequency Financial Data**" (Palgrave Macmillan Publications), "**The Greek Debt Crisis- In quest of Growth at Times of Austerity**" (Palgrave Macmillan Publications) and "**Applications in Energy Finance**" (Springer Publications) while he has edited books in Finance (Broken Hill Publications) and Econometrics (Utopia Publications). His research work has been awarded by the Emerald Publishing, while he has been honored for his contribution by the Hellenic Finance and Accounting Association (HFAA).
